International Service - ACS Europe economy (EU - ECONOMY)

August 2026

Basic Service Description

- This is the most economical ACS international shipping service **from Greece to European destinations**, and is mainly addressed to customers active in e-commerce, *customers contracted with ACS and private customers*.
- The service includes the collection of consignments from the sender's address and the delivery of the consignments in countries of the European Union via **road transport**. The service is only provided by charging the sender.
- Consignment tracking is performed in the same way as in courier services by electronic tracking at all stages of movement (track & trace), whereas delivery is performed upon obtaining the signature of the recipient.
- Each parcel is a separate consignment. Parcels over 40 kg are not supported by this service and are not collected. The minimum dimensions of each consignment are 15cm in width x 15cm in length x 2cm in height and minimum weight is 50 gr. The maximum dimension of a parcel must not be over 150cm.

▪ **Volume Billing**

The charge for each shipment depends on the combination of size and weight. If the volumetric weight of the shipment is greater than its actual weight (such as in the case of light although bulky items), then the charge is based on the volumetric weight and is calculated by multiplying the three dimensions of the parcel and dividing by 3,000.

$$\text{Volumetric weight (in kg)} = \frac{(\text{length}) \times (\text{width}) \times (\text{height}) \text{ in centimeters}}{3.000}$$

Clarifications & Explanations

- 1.** The selection/ use of the service is performed under the responsibility of the customer/sender (and not under ACS responsibility) for cases not described herein. It does not include urgent shipment of sensitive and/or fragile goods. It only includes free Consignments. The charge is always debited to the sender and relates to customers either contracted with ACS or who pay in cash upon collection (receipt) of the consignment by ACS
- 2.** The basic charges prescribed in the price list are subject to the corresponding surcharges provided for in the Basic Price List, when using additional services (such as ACS info, etc.).
- 3.** The service is provided with the cooperation of well-known international European companies and transport networks, respectively. Departures from Greece are daily. The delivery time is subject to potential delays in the transportation routes to the destination (mainly via road). The deliveries and the delivery time to foreign countries pertain mainly to deliveries within the main cities and at the address of the recipient. In the case of deliveries to locations outside cities or remote areas/destinations in foreign countries, and in the event of inaccuracy of the address provided, the time and method of delivery for such consignments may be modified in accordance with the delivery criteria of the carriage companies involved or of their representatives. Such deliveries may be made either at the nearest point of service of the collaborating shipping company or its representative, as the case may be, or be completed at their own discretion in accordance with the procedures followed in that area (in cooperation with another collaborating courier company or global postal service provider of the country concerned). With regard to remote and/or difficult to access Area's delivery time is extended by an extra 1 to 5 working days. Therefore, the total delivery time ranges from 5 to 15 working days, following the departure of the transportation means for the shipment destination, depending on the point of dispatch and the point of destination.
- 4.** ACS makes every effort to deliver consignments according to its schedule and delivery schedules which apply to each area. All delivery times are indicative, pertain to working days and are calculated from the date of departure from Athens or Thessaloniki until the first delivery attempt to the address of the recipient. ACS will not be held liable for damages if delivery times are exceeded.
- 5.** Working days are Monday to Friday, except for national and local holidays. Day means the entire day from 00:01 to 23:59, while collection and delivery usually take place during the opening hours of local stores.
- 6.** ACS reserves the right to request, and the customer is obliged to show identification upon collection/delivery of the consignments made at the place of collection/delivery. As a general rule applying to this service and to the courier service, the recipient states his name and surname, however his identification details are not verified, unless otherwise agreed in writing or the consignment is subject to different treatment under the relevant additional service or subject to the aforementioned case.
- 7.** If a consignment exceeds a weight limit, the next weight level is considered for the calculation of the charge, namely it is rounded up.
- 8.** Consignments are accompanied by a Shipping Note of ACS or of the collaborating foreign company, which may also be entitled Shipping Voucher, Collection/Delivery Voucher, POD Voucher, ACS Connect, AWB, or bear no title at all.
- 9.** Repayment for the services provided can be made either in cash, by credit on the sender or by third party code debit.
- 10.** Any consignment returns (due to non-delivery of consignments) are charged as a new shipment.
- 11.** The transportation services and charges referred to herein are subject to the ACS General Terms and Conditions of Transportation and the Charter of Obligations to Consumers (COC), which can be found on the website www.acscourier.gr.
- 12.** The prices listed herein are subject to VAT (currently 24%). In the event of a change in VAT, prices will also be adjusted according to the applicable VAT.
